

**HARRIS COUNTY COMMUNITY SERVICES DEPARTMENT
ANNUAL ACTION PLAN AMENDMENTS
PUBLIC NOTICE**

June 14, 2010

The U. S. Department of Housing and Urban Development requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submit, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Shelter Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. This strategy document is called the Consolidated Plan and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

2009 HOME Funding:

Project 2009-0055 Harris County CSD Downpayment Assistance Program - obligate \$625,000.00 in 2009 HOME Funds. Total project funding, including previously awarded amounts, will be \$2,125,000.00.

2009 HPRP Funding:

Project 2008-0068 Catholic Charities HPRP Services for Homeless Women - Deobligate \$50,000.00 in 2009 HPRP Rapid Re-housing Funds and obligate \$50,000.00 in 2009 HPRP Homeless Prevention Funds. Total project funding, including previously awarded amounts, will be \$295,796.00.

2003 CDBG Funding:

Project 2010-0055 CSD Harris County Cemetery - Obligate \$4,597.42 in 2003 CDBG Funds, \$56,526.24 in 2004 CDBG Funds, \$6,475.44 in 2005 CDBG Funds, \$39,797.63 in 2006 CDBG Funds, and \$242,603.27 in 2007 CDBG Funds. Total project funding, including previously awarded amounts, will be \$350,000.00.
