

**HARRIS COUNTY COMMUNITY SERVICES DEPARTMENT
ANNUAL ACTION PLAN AMENDMENTS
PUBLIC NOTICE**

November 19, 2010

The U. S. Department of Housing and Urban Development requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submit, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Shelter Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. This strategy document is called the Consolidated Plan and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

2009 ESG Funding:

Project 2009-0050 Harris County CSD Emergency Rental and Mortgage Assistance - deobligate \$60,268.43 in 2009 ESG Funds. Total project funding, including previously awarded amounts, will be \$16,091.57.

2009 HPRP Funding:

Project 2009-0060 Bay Area Turning Point - Deobligate \$21,821.40 in 2009 HPRP HA funds and \$1,091.10 in 2009 HPRP AD funds. Total project funding, including previously awarded amounts, will be \$53,462.50.

Project 2009-0061 Catholic Charities - Deobligate \$15,000.00 in 2009 HPRP HP Funds, \$69,513.00 in 2009 HPRP HA Funds, and \$4,225.80 in 2009 HPRP AD Funds. Total project funding, including previously awarded amounts, will be \$207,057.20.

Project 2009-0062 City of Baytown - Deobligate \$62,500.00 in 2009 HPRP HP Funds, \$62,500.00 in 2009 HPRP HA Funds, and \$5,398.81 in 2009 HPRP AD Funds. Total project funding, including previously awarded amounts, will be \$851.19.

Project 2009-0063 Coalition for the Homeless Houston/Harris County - Obligate \$50,060.00 in 2009 HPRP DC Funds. Total project funding, including previously awarded amounts, will be \$92,060.00.

Project 2009-0065 Harris County Protective Services for Children & Adults - Deobligate \$69,325.50 in 2009 HPRP HP Funds and \$3,466.20 in 2009 HPRP AD Funds. Total project funding, including previously awarded amounts, will be \$169,847.30.
