ANNUAL ACTION PLAN AMENDMENTS
PUBLIC NOTICE

June 16, 2022

The U. S. Department of Housing and Urban Development (HUD) requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submits, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. Other funding addressed includes the Neighborhood Stabilization Program (NSP) I and III and Community Development Block Grant – Disaster Recovery (CDBG-DR), Community Development Block Grant – Coronavirus (CDBG-CV) and Emergency Solutions Grants – Coronavirus (ESG-CV) funds. This strategy document is called the Consolidated Plan, and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

2019 CDBG Funding:

Project 2019-022 HCCSD- Minor Home Repair Program (Countywide). Deobligate \$38,816.59 in 2015 CDBG Funds and Deobligate \$5,448.50 in 2016 CDBG Funds. Project is complete. Total project funding, including previously awarded amounts, will be \$255,452.95.

2020 CDBG Funding:

Project 2020-046 HC Engineering Department- Castlewood Drainage Improvements (Precinct 2). Obligate \$38,816.59 in 2015 CDBG Funds, Obligate \$5,448.50 in 2016 CDBG, and Obligate \$5,539.01 in 2017 CDBG Funds. Total project funding, including previously awarded amounts, will be \$1,261,547.10.

2021 CDBG Funding:

Project 2021-008 Communities in School SE Harris County, Inc., South Houston Youth Intervention Initiative (Precinct 2). Deobligate \$13,253.5 in 2021 CDBG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$28,746.50.

Project 2021-011 Harris County CSD Transportation Program (Countywide). Deobligate \$106,654.09 in 2021 CDBG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$500,844.91.

Project 2021-012 Harris County Precinct One Street Olympics, Inc., Aquatics Program (Precinct 1). Deobligate \$22,857.31 in 2021 CDBG Funds. Total project funding, including previously awarded amounts, will be \$19,166.69.

2021-015 Houston's Capital Investing in the Development and Employment of Adults, Inc. (Capital IDEA)- Career Education Program (Countywide). Deobligate \$16,413.61 in 2021 CDBG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$33,586.39.

Project 2021-018 Precinct2gether Inc., After-School and Summer Day Camp Program (Precinct 2). Deobligate \$79,760.13 in 2021 CDBG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$88,939.87.

Project 2021-019 Precinct2gether Inc., Health University Program (Precinct 2). Deobligate \$23,573.09 in 2021 CDBG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$50,114.91.

2021 ESG Funding:

Project 2021-033c Covenant House Texas, Street Outreach Program for Homeless Youth/Young Adults (Countywide). Deobligate \$29,101.95 in 2021 ESG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$36,793.05.

Project 2021-033g Houston Area Women's Center for Domestic Violence Emergency Shelter Project (Countywide). Deobligate \$24,356.2 in 2021 ESG Funds. Project completed. Total project funding, including previously awarded amounts, will be \$23,878.80.
