

Evaluation of Past Performance (2013-2018)

Harris County has been very successful in meeting many of the objectives in the (2013-2018) Consolidated Plan. Cited below is a list of our major accomplishments. They include:

- Provided 119 households with down payment and closing cost assistance. CSD met 30 percent of the initial goal of 400 households.
- Constructed 6 affordable housing units. CSD met 12 percent of the initial goal of 50 units.
- Acquired 50 new rental affordable multi-family housing units. CSD met 17 percent of initial goal of 300 units.
- Provided minor home repair to 112 households. CSD met 56 percent of its initial goal of 200 units.
- Abated 66 households for lead based paint hazard control. CSD met 51 percent of the initial goal of 130 households.
- Provided emergency and transitional shelter for 13,819 homeless persons. CSD met 34 percent of its initial goal of 41,000 persons.
- Provided 414 homeless persons with rapid rehousing. CSD met 28 percent of the initial goal of 1,500 persons.
- Provided 36 persons with homeless prevention services at risk of homelessness. CSD met 36 percent of the initial goal of 100 persons.
- Provided improvements and or construction of neighborhood centers for no persons. CSD has not met its goal of 2,000 persons.
- Provided improvements to senior center facilities for no persons. CSD has not met the initial goal of 500 persons.
- Provided improvements or construction of parks/recreational facilities for 31,642 persons. CSD met 100 percent of the initial goal of 20,000 persons.
- Provided no persons for improved access to roadways. CSD met has not met its initial goal of 5,000 persons.
- Provided improved access to water/sewer improvements for 95,373 persons. CSD met has met 68 percent of the initial goal of 140,000 persons.
- Provided improved access to sidewalks/pathways for 35,209 persons. CSD met 88 percent of the initial goal of 40,000 persons.
- Provided improved access to flood drainage to no persons. CSD met has not met the initial goal of 5,000 persons.
- Provided general services to 49 persons. CSD has met 2 percent of the initial goal of 2,000 persons.
- Provided senior services 1,960 persons. CSD has met 25 percent of its initial goal of 8,000 persons.
- Provided youth services to 3,764 persons. CSD has met 31 percent of its initial goal of 12,000 persons.
- Provided health services to 733 persons. CSD has met 24 percent of its initial goal of 3,000 persons.
- Provided access to services for persons with disabilities and persons with HIV/AIDS to no persons. CSD has not met the initial goal of 200 persons.
- Provided access to transportation services for 8,393 persons. CSD has met 34 percent of its initial goal of 25,000 persons.
- Provided abused and neglected children services to 1,680 children. CSD has met 56 percent of its initial goal of 3,000 persons.
- Demolished 53 unsafe structures. CSD met 35 percent of its initial goal of 150 structures.
