

**HARRIS COUNTY COMMUNITY SERVICES DEPARTMENT
ANNUAL ACTION PLAN AMENDMENTS
PUBLIC NOTICE**

February 27, 2015

The U. S. Department of Housing and Urban Development requires that Harris County develop a 3- to 5-year strategy document which states the community development and housing needs of the jurisdiction and annually submit, in a single application for funding, its request for Community Development Block Grant (CDBG), Emergency Solutions Grants (ESG) and HOME Investment Partnerships (HOME) Program funds. This strategy document is called the Consolidated Plan and the single application for funding is called the Annual Action Plan (AAP). When significant changes occur to the Consolidated Plan and subsequent AAPs, Harris County must propose amendments to be reviewed by the public for a 30-day comment period. The Harris County Community Services Department (HCCSD) proposes the following amendments:

2015 HOME Funding:

Project C2015-0035 Harris County CSD Downpayment Assistance Program (Countywide) – De-obligate \$1,007,503.00 in 2015 HOME Funds. Total project funding, including previously awarded amounts, will be \$0.00.

2015 CDBG Funding:

Project C2015-0028 Harris County Precinct One Airline ID Zone 2 Water Improvements (Precinct 1) – De-obligate \$1,047,920.00 in 2015 CDBG Funds. Total project funding, including previously awarded amounts, will be 0.00.

Project C2012-0039 Airline Improvement District Zone 2 Lift Station and Force Main (Precinct 1) – Obligate \$1,047,920.00 in 2015 CDBG funds. Total project funding, including previously awarded amount, will be \$2,253,020.00.

2014 CDBG Funding:

Project C2013-0041 The Housing Corporation of Greater Houston – Magnolia Glen/Earl Hatcher Commons (Precinct 1) – Obligate \$550,000.00 in 2014 CDBG Funds. Total project funding, including previously awarded amounts, will be \$1,921,531.86. Change in owner/developer from The Housing Corporation of Greater Houston to the Harris County Housing Authority.

Other Funding:

Project C2013-0041 The Housing Corporation of Greater Houston – Magnolia Glen/Earl Hatcher Commons (Precinct 1) – Harris County, acting as a sub-recipient, will obligate \$500,000 of HOME funds received from the City of Houston. Change in owner/developer from The Housing Corporation of Greater Houston to the Harris County Housing Authority.
